Thank you for your email dated the 24th August, requesting information in relation to cancer waiting times.

The information that you require is as follows:

I am writing to make an open government request for all the information to which I am entitled under the Freedom of Information Act 2000.

Please send me:

- 1. The total number of cancer patients receiving treatment within 62 days.
- 2. The total number of cancer patients waiting more than 104 days for treatment.

Monthly or quarterly data for the January 2019-August 2020 period would be greatly appreciated.

Also, as well as providing the total number, a percentage would be useful. For example, "24% of cancer patients were waiting more than 104 days for treatment."

This information is already publicly available in the cancer waiting times statistics published by NHS England and is therefore exempt under Section 21 of the Freedom of Information Act 2000. The information you require is accessible via the following links.

If you are not satisfied with the outcome of the internal investigation/review, you have the right to apply directly to the Information Commissioner for a decision.
