Thank you for your email dated the 31st March 2021, requesting information in relation to confidential waste.

The information that you require is as follows:

- **Has confidential waste being procured via tender or framework or another means?**
 - **Clatterbridge Cancer Centre – Wirral Site = Other Means - This service is provided to the Trust a part of a Service Level Agreement with Wirral University Teaching Hospital NHS Foundation Trust**
 - **Clatterbridge Cancer Centre – Liverpool Site = Other Means – Direct Award**
 - **Clatterbridge Cancer Centre – Aintree Site = Other Means – Direct Award**

- **If a framework, could you confirm the name of the framework please?**
Not Applicable, see above

- **Actual contract values of each framework/contract (& any sub lots)**
 - **Clatterbridge Cancer Centre – Wirral Site = As these services form part of wider overall Service Level Agreements with Wirral University Teaching Hospital NHS Foundation Trust,**

unfortunately we are unable to break down the cost for these individual services for our Wirral site

- Clatterbridge Cancer Centre – Liverpool Site = Circa £7500 per annum. The amount the Trust is charged is based on a number of variables and does not have a fixed contract value.
- Clatterbridge Cancer Centre – Aintree Site = Circa £840 per annum. The amount the Trust is charged is based on a number of variables and does not have a fixed contract value.

- **Start date & duration of contract.**
 - Clatterbridge Cancer Centre – Wirral Site = Service Level Agreement with Wirral University Teaching Hospital NHS Foundation Trust started April 2013. SLA extended to March 2022
 - Clatterbridge Cancer Centre – Liverpool Site = Start Date – June 2020. Contract is open ended
 - Clatterbridge Cancer Centre – Aintree Site = Start Date - June 2016. Contract is open ended

- **Is there an extension clause in the framework(s)/contract(s) and, if so, the duration of the extension?**
 - Clatterbridge Cancer Centre – Wirral Site = Service Level Agreement with Wirral University Teaching Hospital NHS Foundation Trust has an extension clause (2 x 12 months).
 - Clatterbridge Cancer Centre – Liverpool Site = See answer to question above
 - Clatterbridge Cancer Centre – Aintree Site = See answer to question above
