The Trust uses the Datix risk management system. Currently we are in the process of changing from Datix web to the upgraded Datix cloud IQ. Therefore, the majority of the modules are split across the 2 systems as follows:

Risk assessment and management Incident reporting Claims
Action plans

DatixCloudIQ

Safety alert reporting

The remaining items are stored and recorded as follows:

CQC and/or External Reviews - These are currently not stored in a risk management system and are saved separately.

Mortality and/or Medical Examiner Reviews - We currently use our own inhouse excel spreadsheet for our Mortality Review process. We are in the process of testing the DatixCloudlQ Mortality module.

Audits - We currently use our own in-house built access database for our clinical audit process and a spreadsheet for our process audit plan.
