Thank you for your email dated the 3rd August 2021, requesting information in relation to Celebration of Pride in 2020 and 2021.

The information that you require is as follows:

Please can you provide details of any events, physical installations or infrastructure, or other ways the trust has celebrated LGBT+ Pride, during the calendar years 2020, and 2021 to date.

Please itemise how much each event / physical installation / piece of infrastructure cost the trust. If the cost was funded or part-funded from external funds (e.g. by an NHS-related charity, by a non-NHS charity, or by a community group) please stipulate how much of the funding came from each external source, and how much from trust funds.

If the trust has had more than one event, or put in more than one installation / piece of infrastructure during 2020 and 2021 to date, please give details and a cost breakdown for each separate item.

LGBT+ Pride 2020

The trust launched the NHS rainbow badges to coincide with Pride and also arranged for balloon arches at Clatterbridge Cancer Centre sites. The total costs are summarised below:

Rainbow Badges - £480 (inc. VAT)

Balloon Arches - £500

LGBT+ Pride 2021

To celebrate Pride this year, the Trust shared staff stories from members of our LGBT+ and Allies Staff Network group and the Trust also relaunched the NHS Rainbow badges and had cards printed for these, the cost was as follows:

NHS Rainbow Badge Cards - £80.02 (inc. VAT)

Total cost over both years = £1,060.02
