The information that you require is as follows:

I write to you with a Freedom of Information request regarding the demographics, diversity and experience of high-level and senior leadership of the Trust. This FOI includes gathering information regarding the demographics i.e. marital status, race, gender and leadership experience of the senior leaders within your trust.

I would appreciate it if the survey could be filled out as a Freedom of Information request by the senior members of the Trust Leadership. This includes: Medical Director, Clinical Director, Senior Director and all members of the Executive Team i.e. CEO, CFO, CTO. If this is not possible, I kindly request that the survey be filled out on their behalf.

Exempt under Section 40(2) Personal Information

In accordance with the Data Protection Act 2018 the majority of the information that you have requested falls under the category of *personal information of a third party*, and as such the Trust is unable to release all of the information requested. The common law duty of confidentiality is expected in such matters. This information is therefore exempt under Section 40: Personal Information, of the Freedom of Information Act 2000. Personal information can be requested as a Subject Access Request under the Data Protection Act 2018. However, in order to gain access to personal information, consent of the individual(s) to whom the information is regarding is required.
