The information that you require is as follows:

I write to request information under the Freedom of Information Act.

NHS trusts elective care tracker systems record instances when a patient is removed from a waiting list (e.g. elective admission list or appointment waiting list), and the reason for this removal (see for example https://datadictionary.nhs.uk/attributes/elective admission list removal reason.html).

For each of the separate periods (1) 2017-18, (2) 2018-19, (3) 2019-20, (4) 2020-21, and (5) April-August 2021, please provide:
