1. Please provide the total number of patients treated in the last 3 months for:

Prostate Cancer 898
Metastatic Prostate Cancer 14
Hormone Sensitive Prostate Cancer
Castration Resistant Prostate Cancer

Please note, the Trust does not use the specified SNOMED codes for whether a patient is hormone sensitive or castration resistance, hence this information is not held.
