1. I wish to know how much your trust has spent on specialist equipment for bariatric patients (patients over 160kg) during the last three years?

2. Please give a breakdown of the type of specialist bariatric equipment used by the trust and the amounts spent, split between Rental Expenditure and Purchased Equipment?

Typical bariatric equipment used at the Trust is:

Bariatric bed, standard lease/hire £40 per day Mattress and Pump, standard lease/hire £20 per day Shower chair/commode, standard lease/hire £15 per day Static chair, standard lease/hire £15 per day

Rental expenditure- daily charge is negotiated at the time of requirement for equipment

Purchased equipment- Nil

Ad hoc due to minimal requirement

In 2016, we had 12 patients admitted with weight > 150 kg. In 2017, we had 17 patients admitted with weight > 150 kg.
