Thank you for your email dated 1st February 2018 requesting information regarding TV services.

The information that you require is as follows:

I would like to check about the tv services offered by the hospital please?

The Trust operates a free to air TV system for all in-patient beds and communal spaces.

I wondered which company provides the service?

The Trust procured the TV's and service is maintained by the in-house Estates team.

I wanted a list of each tv package offered, including what is included, the full costs, the duration, and the list of channels this provides access to?

- TV Package Universal live TV and Radio
- Cost to Patient Free
- Duration 24/7 and within acceptable use
- List of Channels Freeview services (TV and Radio) from the Winter Hill transmitter plus Radio Clatterbridge (hospital radio) and BBC Radio Mersevside

I wondered if there are any ways a patient can watch the tv for free and if so what are these periods and how are they accessed?

Service is free and is accessed from bedside monitors or wall mounted TVs in some single bed rooms and waiting areas/common areas.

I wondered which payment methods are available to pay for the tv service and if there are any additional costs such as admin fees etc?



I wondered if refunds are available for the service and if so in what circumstances?



Does the trust profit from this scheme and if so how many in the last financial year?

If you are not satisfied with the outcome of the internal investigation/review, you have the right to apply directly to the Information Commissioner for a decision.
