We are a specialist cancer treatment hospital. We do not have any maternity wards.

We had no unexpected overnight closures.

We closed one inpatient ward overnight on nine occasions; these were unplanned closures between October and December 2017. These closures were the result of low overnight patient numbers or staffing requirements on our other two inpatient wards. Closures were from 8pm to 8am.

We are a cancer treatment hospital specialising in chemotherapy and radiotherapy. We do not offer elective operations.
