Our subsidiaries have been innovative in developing better ways of delivering services to improve patient experience:

- The Clatterbridge Pharmacy Ltd (CPL): was created to provide a better and more timely responsive out-patient and specialist cancer dispensing service, and more latterly drug procurement services on behalf of The Clatterbridge Cancer Centre NHSFT. The establishment of CPL brought provision of these services into the Clatterbridge Group, and put the company on a 'level playing field' to other private sector and community pharmacies.
- PropCare: was established to provide a more client focused and responsive delivery of hard and soft facilities management service across the sites operated by The Clatterbridge Cancer Centre NHSFT.
 PropCare's role also includes oversight, project management, construction and operation under concession of the new Clatterbridge Cancer Centre being built in central Liverpool.
