Thank you for your email dated 25<sup>th</sup> April 2018 requesting information with regards to car parking charges.

The information that you require is as follows:

I am writing under the Freedom of Information Act (2000) to request the following information about car parking charges, income and use of said income at all of your hospitals:

The income earned from hospital car parking charges for the financial years:

## 1. 2014-2015

N.B - Nil -The Clatterbridge Cancer Centre NHS Trust did not charge staff, visitors or patients for car parking.

## 2. 2015-2016

N.B - Please note that car parking deductions for staff began in September 2015. Patients and visitors where not charged for car parking

Income = (£63,396.51)

Expenditure = £62,710.32 (Annual rental of land, pay & display machine, springview barrier, resurface springview car park & general maintenance)

Income - Expenditure = (£686.19)

## 3. 2016-2017

N.B - Patients and visitors where not charged for car parking

Income = (£118,914.46)

Expenditure = £109,872.55 (Annual rental of land, CCTV fault, CDC parking, security hut works, general maintenances, barrier maintenances, car park passes at CCC-Aintree and pay and display machine)

Income – Expenditure = (£9,041.91) (this will be off-set against any proposed increase in staff car parking charges in the future)
