Thank you for your email dated 21st November 2018 requesting information regarding Rheumatoid Arthritis.

The information that you require is as follows:

1. Within your trust how many patients do you have diagnosed with Rheumatoid Arthritis?

As our Trust is a tertiary specialist cancer treatment centre and does not directly treat Rheumatoid Arthritis, this would be recorded as a co-morbidity for our inpatients only. Therefore please see these figures below:

33 of our patients who were discharged between 1st November 2017 and 31st October 2018 had been clinically coded as having a comorbidity of Rheumatoid Arthritis.

2. How many Rheumatoid Arthritis patients have had an IFR [Individual Funding Request] put in for them to have an advanced treatment (i.e. biologic or JAK inhibitor) in the past 12 months?

I can confirm that our Trust does not hold any information in this regard. Our Trust is a tertiary specialist cancer treatment centre and therefore does not treat Rheumatoid Arthritis, if it was thought that patients had RA we would refer out to other Trusts. Therefore, the information you have requested is not applicable to our Trust in this instance.

3. How many patients do you have diagnosed with moderate Rheumatoid Arthritis? [moderate is defined within the guidelines as patients with a DAS score of between 3.2 and 5.1]

When Rheumatoid Arthritis is clinically coded as co-morbidity within our Trust, a DAS score is not assigned. Therefore, we are unable to ascertain the number of patients with moderate Rheumatoid Arthritis from our records.

4. How many moderate Rheumatoid Arthritis patients have had an IFR [Individual Funding Request] put in for them to have an advanced treatment (i.e. biologic or JAK inhibitor) in the past 12 months?
