• How many posts had their job descriptions and timetables approved by the respective royal college?

6 job descriptions and job plans were approved by the respective royal college from 01.09.2017 to 01.09.2018.

For appointments made between 1 September 2016 to 1 September 2017, we had a total number of 4 consultants TUPE from Royal Liverpool and Broadgreen University Hospital and we had assurance that due process was followed for these appointments.

• Were all posts for 10 paid programme appointments with a 7.5:2.5 split of direct clinical care to SPAs?
