- E-cigarettes
- Other (please specify)

Information not held- We only treat 16-18 year olds within our Teenage and Young Adult Unit here at the Clatterbridge Cancer Centre and we do not offer Smoking Cessation Services unless it is simply as a sign posting / referral to existing services.
