Thank you for your email dated 21st February 2019 requesting information regarding gaseous and intravenous anaesthetic agents.

The information that you require is as follows:

I am writing to ask about gaseous and intravenous anaesthetic agents used across your Trust. In particular, I would like to know the total volume and total amount spent individually for EACH of the following agents sevoflurane, desflurane, isoflurane, nitrous oxide, and propofol PER YEAR between 2006 and 2018 as shown below:

- Total (annual) volume purchased for EACH agent (incl. sevoflurane, desflurane, isoflurane, nitrous oxide, and propofol) PER YEAR for 2006-2018 (in millilitres or litres).

Please see Appendix 1 - Please note, the Trust follows best practice guidelines in relation to the retention of accounting information which is a retention period of 7 years and as such we are unable to provide this information before 2011/12.

- Total (annual) volume used for EACH agent PER YEAR for 2006-2018 (in millilitres or litres).

As above

- Total (annual) amount spent on EACH agent PER YEAR for 2006-2108 (in pounds sterling).

The Commercial Medicines Unit (CMU) procures medicines on behalf of the NHS. The prices offered by contractors on CMU contracts are commercially confidential and contractors require CMU to agree not to divulge these prices. CMU Contract prices do not belong to the Trust and hence are not our property to divulge.

Section 43 of the FOIA states 'information is exempt information if it constitutes a trade secret' and 'if its disclosure under this Act would, or would be likely to, prejudice the commercial interests of any person (including the public authority holding it).

When applying Section 43 we have to apply the public interest in withholding/disclosing this information. The use of this exemption is to be carefully considered.

The factors in favour of disclosure of this information, including the general public interest and greater transparency and accountability, were carefully weighed against the need to allow suppliers and organisations the space to conduct their lawful business competitively and without fear of disclosure of sensitive commercial information. On this basis, the Trust feels that the information requested is justifiably exempt under Section 43 of the Act.

If you are dissatisfied with the handling of your request, you have the right to ask for this to be investigated internally.
