Thank you for your email dated 6th March 2019 requesting information regarding the digitisation of patient records.

The information that you require is as follows:

1. What approximate percentage of your patient records – i.e. scans, letters, notes and results – are currently digitised?

- Zero
- 1-25%
- 26-50%
- 51-75%
- <mark>76%-99%</mark>
- All of our patient records are currently digitalised
- 2. Is your NHS Trust planning to digitise all patient records?
 - Yes, we expect all records to be digitised within the next one to two years
 - Yes, we expect all records to be digitised within the next three to four years

- Yes, we expect all records to be digitised within the next five to six years
- All of our patient records are currently digitalised
- We have no plans to digitise patient records

3. How many paper-based patient records did your NHS Trust collect in Q4 2018 (October, November and December)?

A paper light patient record is created for each patient referred to the Trust as they are registered onto the PAS. The Trust received approximately 2665 referrals between Oct-Dec 2018 and therefore, the same number of paper light records were created.

4. Are members of staff receiving training on how to manage digitised patient records?

Yes- Staff receive role specific training in the use of the Electronic Patient Records and Document Management System. They also undergo Information Governance Training and Data Security Training on an annual basis which covers electronic and paper records.
