Thank you for your email dated 29th March 2019 requesting information in regarding IM&T management.

The information that you require is as follows:

1. **On the Executive Management Board of your organisation what is the role/job title of the person with responsibility of digital technology and information within your organisation?**

Director of Finance

2. **What other responsibilities does the role identified in question 1 have in addition to digital technology?**

Digital (IT Operations and Business Intelligence), Finance, Strategy.

3. **If the board level role has digital technology as part of their portfolio, please ask them to estimate what percentage of their time is spent on their digital technology role.**

40%

4. **Does the person in the current board level digital leadership role hold any professional qualifications in digital technology?**

5. What is the NHS pay band for the board role with responsibility for digital technology?

Very Senior Managers

6. Within your organisation what is the Job title of the person with day to day management responsibility for Digital technology.

Chief Information Officer

7. What is the agenda for change pay band for the role identified in question 4.

8. If the role identified in question 4 is a Board member are they a full member with executive voting rights?

Has your board formally discussed changes to the board in relation to digital technology?

Director of Finance, as responsible Executive, has discussed with Chief Executive regarding digital representation at Trust Board. Trust Board has full access to Chief Information Officer (CIO) role

and is brought into executive level discussions for expert Digital advice and strategic input, on a regular basis. The CIO sits on a number of Non Executive Director led sub committees to the Trust Board.

11. Has your organisation got plans in place to discuss changing digital technology leadership at the board level?

The Trust Board programme includes input from the CIO on a regular basis.

12. Has your organisation got a plan to change technology leadership at board level and if so what are the time scales for this to be achieved.

The Trust will review the Board level role, on an annual basis.

13. On average over the past 3 years what is the total annual revenue spending on digital technology systems and services within your organisation? I am looking for a total figure for all of the recurring revenue spending on staff, systems, licensing, 3rd party support etc.

14. On average over the past 3 years what is the total annual capital spending on digital technology systems and services within your organisation. Again, I am looking for a total figure for spending on hardware, software, systems, 3rd parties, project management and implementation etc.

£2.3M p.a.
