Thank you for your letter, received into the Trust on the 4th June 2019 requesting information in relation to cleaning and contracts.

The information that you require is as follows:

What cleaning methods does the trust currently use for room and theatre disinfection?

In both of our main sites of Clatterbridge Cancer Centre –Wirral (CCC-W) and Clatterbridge Cancer Centre- Aintree (CCC-A), manual cleaning is undertaken by domestic staff using detergent and water and disinfection is undertaken using a chlorine based agent. Additional disinfection is undertaken if necessary using Hydrogen peroxide or UV-C. We do not conduct surgical procedures in any of our sites, these are therefore non-surgical theatres.

Our Haemato-Oncolocy Unit is based in the Royal Liverpool Hospital and such services are delivered through arrangements made by the Royal Liverpool Hospital. In order to gain this information for our Haemato-

Domestic staff are provided as part of Service Level Agreements between the following:

- CCC-W site and Wirral University Teaching Hospital
- CCC-A and The Walton Centre
- Haemato- Oncology- Royal Liverpool Hospital

Does the trust currently have UVC machines for decontamination? If so how many units and which supplier/ manufacturer?

Yes, at CCC-W we currently have 1 UV-C machine which was supplied by Hygiene Solutions. This is not applicable to CCC-A.
