Thank you for your email dated the 11th June 2019, requesting information with regards to end of life care statistics.

The information that you require is as follows:

The percentage of patients who have died on the Trust's end-of-life care plan against the Trust's target for the number of patients who should die on this plan over the last three years, divided by the year.

e.g. Between 1 January 2016 and 31 December 2016, 43 per cent of patients died on the plan against a target of 35 per cent.

Note: If no such target exists, please make this clear.

The figures below represent the number and percentage of in-patient deaths that have been supported by the End of Life Care Plan. There are no definitive targets set with regards to this within our Trust, we are therefore unable to compare this against the Trust's target for the number of patients who should die on this plan.
