The Trust has purchased all its current mattresses.

2. When is this contract due to end?

The Trust has a service contract for mattress pumps with the supplier

6. Does this contract cover bariatric as well?

The service contract is for all mattresses including bariatric

All beds are newly purchased in November 2018, and remain under warranty

9. How many static (foam) mattresses on average does The Clatterbridge Cancer Centre NHS Foundation Trust purchase in a year?

We are unable to provide a yearly average. The Trusts replacement programme is based on the manufacturers recommended shelf life of the product, these mattresses have an expected shelf life of 7 to 10 years. The Trust completed a total replacement programme in 2016 which included 64 hybrid mercury advance mattresses and 35 air pumps.

10. Which manufacturers products do you use and Is this under contract?

Beds were purchased from Arjo and mercury hybrid advance mattresses purchased through Direct HealthCare

11. Who is the main Tissue Viability Nurse for the Trust?

The Trust does not have a main Tissue Viability Nurse. However, the Trust has a number of healthcare professionals with extended tissue viability knowledge to support safe care being delivered.

12. Who is the main Procurement Manager for The Clatterbridge Cancer Centre NHS Foundation Trust
