May you please provide the following:

- 1) The total amount of compensation payments paid out to NHS staff
 - a) May you please provide the figures per year within the past three financial years (2019/18, 2018/17, and 2017/2016)
 i.e. in 2018/17, the Trust paid out 10 compensation claims to staff

In 2018/19 the Trust paid out 1 compensation claim to staff In 2017/18 the Trust paid out 1 compensation claim to staff In 2016/17 the Trust paid out 1 compensation claim to staff

- 2) The total cost of compensation payments paid out to NHS staff
 - May you please provide the figures per year within the past three financial years (2019/18, 2018/17, and 2017/2016)
 i.e. in 2018/17, the Trust paid out 10 compensation claims amounting to £35,000

In 2018/19 the Trust paid out £3k In 2017/18 the Trust paid out £3k In 2016/17 the Trust paid out £3k

- 3) In each instance, may you please further detail on the nature/ reason behind the compensation payments for example, exposure to toxic substances, assaults from patients, slips / falls on the ward
 - a) i.e. in 2018/17, the Trust paid out 10 compensation claims amounting to £35,000. 6 claims related to exposure of toxic substances and 4 claims related to individuals who suffered slips/ falls on the ward All three of these compensation payments were due to needlestick injuries.
