Thank you for your email dated the 5th November 2019, requesting information relating to travel by Trust staff.

The information that you require is as follows:

How many business miles have been travelled by trust employees using their own car (greyfleet) in the last 12 months?

Between the 01 OCT 2018 – 30 SEP 2019: 234,174.59 miles

How much money has been reimbursed back to employees for those business miles for greyfleet in the last 12 months?

Between the 01 OCT 2018 – 30 SEP 2019 (Sum of NET):

£125,947.14

How much does the trust reimburse its employees per mile?

How many miles did trust employees drive in the last 12 months in any type of vehicle e.g. greyfleet, trust owned, car rental, car club etc.?

Records show that Trust employees have driven 234,174.59 miles in the last 12 months.

Our Trust also has Chemotherapy cars delivering home treatment.

Unfortunately, this information for these cars is not currently recorded.

However, we can confirm that these cars do not travel more than approximately 20,000 miles per year.

Does the trust have an employee travel policy for business travel, which may include other additional modes of transport such as train, car rental etc.?
