Thank you for your email dated the 28th January 2020, requesting information regarding First Aid Training and Mental Health Training.

The information that you require is as follows:

 What First Aid Training and Mental Health Training, if any, do you provide to your staff?

At present, our Trust has 3 staff members who have completed the Mental Health First Aid training and 2 of those staff are instructors in Mental Health First Aid.

We have a current training plan in place (as part of the pledges within the Trust Patient Experience Strategy) to internally train 12 more staff in March and 12 staff in April 2020 to become Mental Health First Aiders.

Our Trust provides a 3 day First Aid at work Certificate for staff.

 The current provider of First Aid Training and Mental Health Training to your staff and contract expiry date

The current provider to Clatterbridge Cancer Centre of Mental Health First Aid Training is Mental Health First Aid England. We do not have a contract with this provider; we have accessed their training for our staff through the company website.

The Trust employs an external provider to deliver the First Aid training, and this will be based on a need to replace the number of first aiders as required. There is no expiry contract date and Trust uses Coniston Associates.
