Thank you for your email dated the 15<sup>th</sup> October 2020, requesting information in relation to Covid related capital bids.

The information that you require is as follows:

**I would like to know how many covid-related capital bids have been approved centrally since March 17 and was hoping you could answer a few questions. I've attached a spreadsheet with questions, that should make it easy to record each of the bids your trust has submitted. I've included an example in the spreadsheet.**

**To avoid confusion, covid-19 related capital refers to bids submitted in respect of the covid-19 capital expenditure scheme <https://www.england.nhs.uk/coronavirus/wp-content/uploads/sites/52/2020/04/COVID-19-capital-reimbursement-process-27-04-20.pdf>. All other types of capital bids should not be included.**

**In addition, can you please tell me:**

- **The total value of your covid-related capital bids**
- **The total in funding you've received for covid-related capital bids.**
- **How many bids you have made and how many are awaiting central approval.**
