The information that you require is as follows:

1 – The latest figure you have for the number of items of PPE issued to the Trust since the coronavirus pandemic began.

Information not held by the Trust - The Trust does not hold exact information with regard to the specific number of items of PPE issued to the Trust since the coronavirus pandemic began.

2 - If the figure contains a breakdown of gloves, masks, aprons, face visors and gowns, please let us know the numbers for those items. Information not held by the Trust, See answer to Question 1

3 – If you have the figure, the cost of the PPE which has been issued to the Trust during the pandemic.

Disposal of PPE is included in the existing clinical waste contracts and SLAs the Trust has in place.

Our clinical waste service contracts for our three Trust sites are as follows:

- The Clatterbridge Cancer Centre Wirral (CCCW) The Trust has a Service Level Agreement (SLA) with Wirral University Teaching Hospital NHS Foundation Trust (WUTH)
- The Clatterbridge Cancer Centre Aintree (CCCA) The Trust has a Service Level Agreement (SLA) with The Walton Centre NHS Foundation Trust
- The Clatterbridge Cancer Centre Liverpool (CCCL) The Trust has a contract with SRCL (Stericycle)

No new contracts have been put in place to dispose of the used PPE.

6 – The cost of disposal of PPE so far this year, and the cost last year. See answer to Question 4

7 - Whether the Trust has any concerns that PPE awaiting disposal poses a health risk, or could pose such a risk in the near future. No concerns have been recorded. Frequent collections mean PPE is removed in a timely manner.
